 - c. acceptance of site and/or easement conveyance for facilities constructed or to be constructed for the District, and the taking of any action in connection therewith;
 - d. discuss construction of emergency water supply interconnect and take any action thereon; and
 - e. review feasibility study in connection with providing service to a 23.34 acre tract and take any action thereon;
11. Review Capital Improvement Plan;
12. Hear Operator's Report, including:
 - a. review of delinquent accounts and take any action thereon;

13. Hear report from Storm Water Solutions and take any action thereon, including:
 - a. review wetlands permit and consider proposal for maintenance of green space;
